VOLUNTEER JOB DESCRIPTION

CRISIS CALL VOLUNTEERS:

- i) The volunteer will receive direction and support from the Volunteer Coordinator.
- ii) The volunteer responds to a crisis situation (i.e. calls to the scene) and provides:
 - Emotional support to the victim(s)
 - Answer questions and provide referral information for further assistance.
 - Court information and assistance (referral to Victim/Witness Assistance).
 - Information on Criminal Injuries Compensation.
 - Education on crime prevention and home security measures (i.e. Neighbourhood Watch)
 - Assist with clean up and gives aid with any practical support.
 - Crisis intervention and mediation for immediate situation only.
 - Referral to Coordinator for any follow-up service, as necessary.
- iii) The volunteer submits a written report the next day of the occurrence.
- iv) Volunteers will attend on-going training sessions and 8 out of 10 monthly volunteer meetings.
- v) Volunteers must be responsible for their time commitment.
